- 1. This offer is open to legal residents of the 50 United States and the District of Columbia making purchases in those locations. The mail-in offer is not transferable and is valid only for the individual who purchased the products for personal household use.
- 2. Approved claims will receive the reward in US dollars in the form of a Mastercraft Tires Visa* Prepaid Card, to be mailed to the address provided on this Official Mail-in Form. This card is issued by CenterState Bank of Florida, NA pursuant to a license from Visa U.S.A. Inc. The card requires activation by the recipient and then is accepted everywhere Visa debit cards are accepted. The card cannot be used for cash withdrawal at an ATM. The card will arrive attached to a card mailer. Carefully read all information provided on the mailer regarding activation and use of the card. This card is not a line of credit and will expire 12 months from the month of issuance.
