1. This offer is open to legal residents of the 50 United States and the District of Columbia making purchases in participating retail stores in those locations. The mail-in offer is not transferable and is valid only for the individual who purchased four new qualifying Mastercraft Tires in a single transaction for personal household use. Void where restricted or prohibited by law.

Properly submitted and verified claims will be provided with the reward (as described below) in U.S. dollars in the form of a Mastercraft Tires Visa® Prepaid Card, to be mailed to the address provided on this official mail-in form.
